Objectives

MITEX is committed to the following objectives to protect the environment and promote a sustainable future:

Energy efficiency and renewable energy:

- Target of 100% electrified cars in the fleet by the end of 2026.
- Expansion of own renewable energy generation by modernizing roof surfaces and equipping them with photovoltaics. Target of expanding photovoltaics to 90% of economically viable roof areas by the end of 2024.
- Use of 100% LED technologies by the end of 2024.

Conservation of resources

- Reduction of Scope 1 and 2 emissions by 10% by the end of 2026.
- Quantification of total Scope 1-3 emissions by the end of 2025. Based on the result, setting an ambitious target to reduce total emissions by the end of 2030.

Sustainable procurement:

- Continue the sustainable procurement policy in accordance with the MITEX purchasing policy and increase the incentives and requirements for certified sustainable suppliers. Expand quantification system and reporting by the end of 2024.

Biodiversity:

- Protection and promotion of biodiversity close to the company and support for local initiatives.

Employee engagement and education:

- Annual support of local and global charitable projects and offers for employees to participate in these.
- Active involvement of employees in sustainability initiatives and promotion of environmental awareness, e.g. through annual training courses.

These objectives are an integral part of our corporate strategy and reflect our commitment to sustainable business practices. If, in individual cases, the simple wording of the objectives conflicts with sustainable action, sensible decisions are made on a case-by-case basis.

- Audit of a voluntary charitable project
